Subject: **Government Order (GO) for Participation in the High-Level 12th Regional 3R and Circular Economy Forum in Asia and the Pacific in Jaipur, India, from 3 to 5 March 2025**

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Mr. Md. Rezaul Karim, Joint Secretary**, Ministry of Environment, Forest and Climate Change, to attend the "High-Level 12th Regional 3R and Circular Economy Forum in Asia and the Pacific," scheduled to take place in **Jaipur City, State of Rajasthan, India**, from 3 to 5 March 2025. This approval is granted in accordance with the terms and conditions outlined below:

2. Terms and conditions

- i. The officer will commence his journey to **Jaipur, India** on a convenient date near 3 March 2025;
- ii. The period of the forum, along with the time spent on travel and transit, will be treated as on duty;
- iii. He will draw his pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. The United Nations Centre for Regional Development (UNCRD) will bear all expenses of the above participant for the aforesaid forum. **There will be no financial involvement from the Government of Bangladesh;**
- v. He will not be allowed to stay abroad beyond the approved period (except for travel time);
- vi. He must return to his workplace immediately after completing the forum; and
- vii. He is required to submit a report on the forum to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.

3. This order is issued with the approval of the competent authority.


