The undersigned is directed to convey the approval of the Ministry of Environment, Forest, and Climate Change, Government of the People's Republic of Bangladesh for **Mr. Md. Shofiqul Islam, Divisional Forest Officer, Coastal Forest Division, Bangladesh Forest Department, Patuakhali** to attend the training course titled **"Developing Policy Making Abilities for Sustainable Forest Management" (202311646J001)**. This course is scheduled to take place from **05 November to 04 December 2024** in **Japan** and is part of the project aimed at enhancing coastal resilience through technology-based forest management. - v. He will not be allowed to stay abroad more than the approved period (except travel days);
- vi. The Officer shall return to his workplace immediately upon returning from the training course and
- vii. He will have to submit reports on the training course to the Admin-2 section of the Ministry of Environment, Forest and Climate Change within seven days after his return from the course.
