2. Terms and conditions:

- i. The Officers will start their journey for **Nepal** on a convenient date near September 25, 2024;
- ii. The period of this dialogue and the time spent for travel and transit will be treated as on duty;
- iii. They will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. International Centre for Integrated Mountain Development (ICIMOD) and its partners will bear all expenses related to their participation in the aforesaid dialogue. **There will be no financial involvement from the Government of Bangladesh;**
- v. They will not be allowed to stay abroad more than the approved period (except travel days);
- vi. The Officers shall return to their workplace immediately upon returning from the dialogue and
- vii. The Officers will have to submit reports on the dialogue to the Admin-2 section of the Ministry of Environment, Forest and Climate Change within seven days after their return from the event.


