Subject: **Subject: Government Order (GO) for Participation in the Regional Marine Protected Areas (MPA) and IUCN Green List Training in Thailand**

The undersigned is directed to convey the approval of the Ministry of Environment, Forest and Climate Change, Government of the People's Republic of Bangladesh, for **Mr. Sayad Mahmudur Rahman, Mammalogist**, Development Planning Unit, Forest Department, Dhaka, to participate in the "Regional Marine Protected Areas (MPA) and IUCN Green List Training for BOBLME Implementing Partners" scheduled to be held from **26 to 30 May 2025 in Koh Man Nai, Thailand**, organized by the IUCN Asia Regional Office. This approval is accorded under the following terms and conditions:

2. Terms and conditions

- i. The official will commence his journey to Thailand on or around 24 May 2025 and return after the completion of the training;
- ii. The entire duration of the visit, including travel and transit, shall be considered as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to his participation, including airfare, accommodation, meals, local transportation, and visa processing, will be borne by the IUCN Asia Regional Office. There will be no financial involvement from the Government of Bangladesh;
- v. He will not stay abroad beyond the approved period (except for travel time);
- vi. He must report back to his office immediately upon completion of the program; and
- vii. He is required to submit a report on the program to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.

3. This order is issued with the approval of the competent authority.


