
Subject: **Government Order (GO) for Participation in the Training Course on "Enhancing Access to Climate Finance - Theory and Application for Practitioners (202311658J001)" in Japan, 09 December 2024 – 09 January 2025 (Online) and 14 January 2025 – 10 February 2025 (In-person)**

The undersigned is directed to convey the approval of the Ministry of Environment, Forest and Climate Change, Government of the People's Republic of Bangladesh, for **Mr. Md Mirza Asadul Kibriya, Assistant Director** (Climate Change & International Convention Wing), Department of Environment, Headquarters, Dhaka, to attend the training course on "Enhancing Access to Climate Finance - Theory and Application for Practitioners (202311658J001)". The course will be conducted in two phases: an online session from 09 December 2024 to 09 January 2025, followed by an in-person training session in **Japan** from **14 January 2025** to **10 February 2025**. This approval is in accordance with the terms and conditions outlined in paragraph 2.

2. Terms and conditions

- i. The Officer will start his journey for **Japan** on a convenient date near 14 January 2025;
- ii. The period of this training course, along with the time spent for travel and transit, will be treated as on duty;
- iii. He will draw his pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. Japan International Cooperation Agency (JICA) will bear all expenses of the aforesaid training course. **There will be no financial involvement from the Government of Bangladesh;**
- v. He will not be allowed to stay abroad more than the approved period (except travel time);
- vi. He must return to his workplace immediately after completing the training course and
- vii. He is required to submit a report on the training course to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.

3. This order is issued with the approval of the competent authority.
