2. Terms and conditions

- iii. They will draw their pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to their participation in the event(s) will be borne by the ESCAP Secretariat/Event Organizer(s). **There will be no financial involvement from the Government of Bangladesh;**
- v. They will not stay abroad beyond the approved period for their respective programs (except for travel time);
- vi. They must report back to their respective offices immediately upon completion of the program; and
- vii. They are required to submit a report on the event(s) to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven days of her return.


