Subject: **Government Order for H.E. Ms. Syeda Rizwana Hasan's Participation in the Ministerial Segment of INC-5.2 in Geneva, Switzerland**

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for Her Excellency **Ms. Syeda Rizwana Hasan** (Passport No. **D00017713**), **Honorable Adviser** to the Ministry of Environment, Forest and Climate Change as well as the Ministry of Water Resources, to attend the "*Ministerial Segment of the Fifth Session (Part II) of the Intergovernmental Negotiating Committee (INC-5.2) on Plastic Pollution*", scheduled to be held from **12 to 14 August 2025 in Geneva, Switzerland**. This approval is accorded under the following terms and conditions:

2. Terms and conditions
 - i. Her Excellency may commence her journey to Switzerland on or around 11 August 2025 and return to Bangladesh on or around 15 August 2025, subject to flight availability and travel convenience;
 - ii. The duration of the visit, including travel and transit, shall be considered on duty;
 - iii. Her Excellency shall draw her pay and allowances in local currency. No part of it shall be drawn in foreign currency;
 - iv. The expenses for airfare, accommodation, per diem, and other eligible expenses during her participation in the event will be funded by World Bank. Any additional expenditure, if required for protocol obligations or to fulfill entitlements as per government rules, may be met from the Cabinet Division's budget under code **03-1040301-100121-3244101**; and
 - v. She will not stay abroad beyond the approved period, except for necessary travel time.
3. This order is issued with the approval of the competent authority.
