2. Terms and conditions

 - iii. The official shall draw her pay and allowances in local currency; no part of it shall be drawn in foreign currency;
 - iv. All expenses related to her participation in the event(s) will be borne by the Asian Development Bank (ADB) as per their rules and regulations. **There will be no financial involvement from the Government of Bangladesh;**
 - v. The official shall not stay abroad beyond the approved period (except for travel time);
 - vi. She must report back to her office immediately upon completion of the event(s); and
 - vii. She is required to submit a report on the forum and side events to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven (7) working days of return.
