2. Terms and conditions

- i. The officials will commence their journey to Nepal on or around 14 September 2025 and return on or around 20 September 2025, depending on travel convenience;
- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. They will draw their pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to their participation in the conference will be borne by ICIMOD. **There will be no financial involvement from the Government of Bangladesh;**
- v. They will not stay abroad beyond the approved period (except for travel time);
- vi. They must report back to their respective offices immediately upon completion of the program; and
- vii. They are required to submit a report on the workshop to the Administration-2 Section of the Ministry of Environment, Forest and Climate Change within seven days of their return.
