2. Terms and conditions

- i. The official will travel to Addis Ababa, Ethiopia on or around 26 July 2025 and return to Bangladesh on or around 30 July 2025, subject to flight availability and travel convenience;
- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. The official shall draw his pay and allowances in local currency; no part of it shall be drawn in foreign currency;
- iv. All expenses related to his participation in the event will be borne by Asian Development Bank (ADB) as per their rules and regulations. There will be no financial involvement from the Government of Bangladesh;
- v. The official shall not stay abroad beyond the approved period (except for travel time);
- vi. He must report back to his office immediately upon completion of the event; and
- vii. He is required to submit a report on the event to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven (7) working days of return.
