2. Terms and conditions

- i. The official will commence his journey to Germany on or around 01 November 2025 and return on or around 12 November 2025, depending on travel convenience;
- ii. The entire duration of the visit, including travel, seminar sessions, research stay, and transit, shall be treated as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. The **Organizers (Technische Universität Dresden and UNU-FLORES)** will bear all expenses during the seminar period (02–08 November 2025). Expenses for the **Guest Researcher stay (09–11 November 2025)** shall be borne entirely by Mr. Md Saifur Rahman on his own initiative. Accordingly, there will be **no financial involvement from the Government of Bangladesh** in connection with this visit;
- v. He will not stay abroad beyond the approved period (except for travel time);
- vi. He must report back to his office immediately upon completion of the program; and
- vii. He is required to submit a report on the event(s) to the Administration-2 Section of the Ministry of Environment, Forest and Climate Change within seven days of return.
