
Subject: **Government Order for Participation in the 47<sup>th</sup> OEWG and 74<sup>th</sup> IMPCOM Meetings of the Montreal Protocol, 7-11 July 2025, Bangkok, Thailand**

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for the following officials to participate in the 47<sup>th</sup> Meeting of the Open-ended Working Group (OEWG) and the 74<sup>th</sup> Meeting of the Implementation Committee (IMPCOM) under the Montreal Protocol on Substances that Deplete the Ozone Layer. These meetings will be held from 7 to 11 July 2025 at the United Nations Conference Centre (UNCC), ESCAP, **Bangkok, Thailand**, organized by the United Nations Environment Programme (UNEP).

2. Terms and conditions
  - i. The officials will commence their journey to Thailand as well as return upon completion of the program on or around 12 July 2025, depending on travel convenience;
  - ii. The entire duration of the visit, including travel and transit, shall be considered as on duty;
  - iii. The officials will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency;
  - iv. All expenses related to the participation of Mr. Md. Sohrab Ali will be borne by the UNEP, and for Mr. Md Mahiuddin Manik, by the UNDP-funded Institutional Strengthening Project (Phase-X).  
**There will be no financial involvement from the Government of Bangladesh;**
  - v. They will not stay abroad beyond the approved period (except for travel time);
  - vi. They must report back to their office immediately upon completion of the meetings; and
  - vii. They are required to submit a report on the meetings to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of her return.
