Subject: **Government Order (GO) for Participation in the Forty-Fourth Meeting of the Adaptation Fund Board and the Thirty-Fifth Meeting of the Board Committees in Bonn, Germany**

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Mr. Md. Mahmud Hossain, Deputy Director**, Department of Environment, Dhaka, to participate as the Adaptation Fund Board Alternate in the Forty-Fourth Meeting of the Adaptation Fund Board and the Thirty-Fifth Meeting of the Board Committees, scheduled to be held from **8 to 11 April 2025 in Bonn, Germany**. Additionally, he will attend an informal consultation session on the Paris Agreement and other key board topics on **7 April 2025**. The meetings will take place at the headquarters of the United Nations Framework Convention on Climate Change (UNFCCC), Bonn, Germany. This approval is granted in accordance with the following terms and conditions:

2. Terms and conditions


- i. The official will commence his journey for Bonn on a convenient date near 7 April 2025;
- ii. The duration of the meetings, including travel and transit time, will be treated as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to his participation will be covered by the Adaptation Fund through its secretariat. **There will be no financial involvement from the Government of Bangladesh;**
- v. He will not stay abroad beyond the approved period (except for travel time);
- vi. He must return to his workplace after completing the program; and
- vii. He is required to submit a report on the meetings to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.
