2. Terms and conditions

- i. The officer will start her journey to **Geneva** on a convenient date near **3 February 2025**;

- iii. She will draw her pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. The Secretariat of the Basel, Rotterdam and Stockholm Conventions will bear all expenses of the above participant for the aforesaid training. **There will be no financial involvement from the Government of Bangladesh;**
- v. She will not be allowed to stay abroad more than the approved period (except travel time);
- vi. She must return to her workplace immediately after completing the training; and
- vii. She is required to submit a report on the training to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within fifteen days of her return.
