The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Mr. Sidhartha Sankar Kundu, Deputy Secretary**, Ministry of Environment, Forest and Climate Change, Dhaka to participate in the Consulting Workshop for Technical Assistance Strategy within the RAPAP Framework, scheduled to be held on **2 May 2025** at the United Nations Conference Centre (UNCC), **Bangkok, Thailand**. 2. Terms and conditions

- ii. The duration of the visit, including travel and transit, will be treated as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. The United Nations Economic and Social Commission for Asia and the Pacific (ESCAP) will bear all expenses related to the participation of the official in this workshop. **There will be no financial involvement from the Government of Bangladesh;**
- v. He will not stay abroad beyond the approved period (except for travel time);
- vi. He must return to his workplace after completing the program; and
- vii. He is required to submit a report on the workshop to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.
