

2. Terms and conditions

 - iii. The officials will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency;
 - iv. All expenses related to their participation will be borne by the Asian Institute of Technology (AIT) RRC.AP as per their policy. **There will be no financial involvement from the Government of Bangladesh;**
 - v. They will not stay abroad beyond the approved period (except for travel time);
 - vi. They must report back to their respective offices immediately upon completion of the workshop; and
 - vii. Each official must submit a report on the program to the Administration-2 Section of the Ministry within 7 (seven) working days of return.
