2. Terms and conditions

- v. They will not stay abroad beyond the approved period (except for travel time);
- vi. They must return to their respective workplaces immediately after completing the meeting; and
- vii. Both officials are required to submit a report on the meeting to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of their return.
