Deputation Order

The undersigned is directed to convey the Government's approval of deputation to Mr. Md. China from 07 September, 2025 to 30 June, 2027 under the following terms and conditions:

- b. The approved period of this course and the time spent for travel and transit will be treated as on duty;
- c. He will draw all parts of his pays and allowances in local currency and not in foreign currency;
- d. All expenses related to this program will be borne by Nanjing Forestry University, Nanjing City, Jiangsu Province, P.R. China accredited by Ministry of Education China;
- e. He will not be allowed to stay abroad more than the approved period;
- f. Before being considered for another overseas programme, he will have to serve the government for One year after returning from the programme;
- g. He will have to submit a report on the course to the Foreign Training Branch of the Ministry of Environment, Forest & Climate Change within five days after his return from the Course.


