- iv. Secretariat of the Basel, Rotterdam and Stockholm Conventions will bear all expenses related to his participation in the aforesaid workshop. **There will be no financial involvement from the Government of Bangladesh;**
- v. He will not be allowed to stay abroad more than the approved period (except travel days);
- vi. The Officer shall return to his workplace immediately upon returning from the workshop and
- vii. The Officer will have to submit reports on the workshop to the Admin-2 section of the Ministry of Environment, Forest and Climate Change within seven days after his return from the event.


