2. Terms and conditions

 - iii. She will draw her pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - iv. All expenses related to her participation in the dialogue will be borne by the organizer(s) (UNDP-BIOFIN-the United Nations Development Programme's Biodiversity Finance Initiative). **There will be no financial involvement from the Government of Bangladesh;**
 - v. She will not stay abroad beyond the approved period (except for travel time);
 - vi. She must report back to her office immediately upon completion of the program; and
 - vii. She is required to submit a report on the dialogue to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven days of her return.
