2. Terms and conditions
 - i. The official will travel to Indonesia on or around 10 August 2025 and return to Bangladesh on or around 15 August 2025, subject to flight availability and travel convenience;
 - ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
 - iii. The official shall draw his pay and allowances in local currency; no part of it shall be drawn in foreign currency;
 - iv. All expenses related to his participation in the event will be borne by UNIDO as per their rules and regulations. **There will be no financial involvement from the Government of Bangladesh;**
 - v. The official shall not stay abroad beyond the approved period (except for travel time);
 - vi. He must report back to his office immediately upon completion of the program; and
 - vii. He is required to submit a report on the study tour to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven (7) working days of return.
