2. Terms and conditions

- iii. She will draw her pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. IUCN will bear her round-trip economy-class airfare, accommodation, and daily subsistence allowance for participation in the Congress. Any additional expenses, if applicable, shall be met from the travel expenses budget of the Ministry of Environment, Forest and Climate Change (Budget Code: 42-1450101-124496-3244101) as per entitlement; and
- v. She will not stay abroad beyond the approved period, except for necessary travel time.
