

The undersigned is directed to convey the approval of the Ministry of Environment, Forest, and Climate Change, Government of the People's Republic of Bangladesh, for **Ms. Dil Afruza Begum, Deputy Secretary**, Ministry of Environment, Forest, and Climate Change, to attend the 'Community Resilience Partnership Program (CRPP) Partnership Forum 2025' scheduled to take place in **Bangkok, Thailand**, from **25 to 26 February 2025**. This approval is granted in accordance with the terms and conditions outlined below

2. Terms and conditions

- i. The officer will start her journey to **Bangkok** on a convenient date near **25 February 2025**;
- ii. The period of this forum, along with the time spent for travel and transit, will be treated as on duty;
- iii. She will draw her pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. The Asian Development Bank (ADB) will bear all expenses of the above participant for the aforesaid forum. **There will be no financial involvement from the Government of Bangladesh**;
- v. She will not be allowed to stay abroad more than the approved period (except travel time);
- vi. She must return to her workplace immediately after completing the forum; and
- vii. She is required to submit a report on the forum to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of her return.


