

2. Terms and conditions
 - i. The officials will commence their journey to South Korea on or around 24 August 2025 and return on or around 30 August 2025, depending on travel convenience;
 - ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
 - iii. They will draw their pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - iv. All expenses related to their participation in the training course will be borne by the organizer(s) [Korea Adaptation Center for Climate Change]. **There will be no financial involvement from the Government of Bangladesh;**
 - v. They will not stay abroad beyond the approved period (except for travel time);
 - vi. They must report back to their office immediately upon completion of the program; and
 - vii. They are required to submit a report on the training course to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven days of their return.
