- i. While participating in the sessions and on journey to and from Geneva, Switzerland, they will be treated as on duty;
- ii. They will draw their pay and allowances in local currency during the aforesaid period;
- iii. All expenses related to this visit will be borne by the respective sponsoring organizations as mentioned above. However, in case the funding body do not fully cover the entitlements of the Hon'ble Advisor, Secretary, Additional Secretary or officials of the same hierarchy as per Government rules, the remaining amount will be borne by the Government of the People's Republic of Bangladesh from the respective revenue budgets as follows:
 - For the Hon'ble Advisor: from the Cabinet Division under budget code - Travel Expenses: 03-1040301-100121-3244101;
 - For the Secretary and the Additional Secretary or officials of the same hierarchy: from the Ministry of Environment, Forest and Climate Change under budget code – Travel Expenses: 03-1450101-124496-3244101 and the Department of Environment under budget code – Travel Expenses: 1450301-124572-3244101.
 - For all other delegates, there is no financial involvement of the Government of Bangladesh.
- iv. They will not stay abroad beyond the approved period (excluding travel time);
- v. They will return to their respective work place immediately after returning from the meeting; and
- vi. They will submit a report on the acquired experiences to this Ministry within 10 working days after their return to Bangladesh.
