
Subject: **Government Order (GO) for Participation in the Training Course on "Early Warning System and Climate Change Adaptation", China (09–23 September 2025)**


This approval is accorded under the following terms and conditions:

2. Terms and conditions
 - i. The official will commence her journey to China on or around 08 September 2025 and return on or around 24 September 2025, depending on travel convenience;
 - ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
 - iii. She will draw her pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - iv. All expenses related to her participation in the training course will be borne by the organizer/Ministry of Ecology and Environment, the People's Republic of China. **There will be no financial involvement from the Government of Bangladesh;**
 - v. She will not stay abroad beyond the approved period (except for travel time);
 - vi. She must report back to her office immediately upon completion of the program; and
 - vii. She is required to submit a report on the training course to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven days of her return.
