

2. Terms and conditions


- i. The official will commence her journey to Bangkok, Thailand on or around 09 November 2025 and return on or around 15 November 2025, subject to travel convenience;
- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. She will draw her pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to her participation, including registration fee, accommodation, per diem, and airfare reimbursement, will be borne by the **Chulabhorn Research Institute (CRI)**. **There will be no financial involvement from the Government of Bangladesh**;
- v. She will not stay abroad beyond the approved period (except for unavoidable travel time);
- vi. She must report back to her office immediately upon completion of the program; and
- vii. She is required to submit a report on the program to the Administration-2 Section of the Ministry of Environment, Forest and Climate Change within seven (07) days of her return.
