Subject: **Government Order (GO) for Participation in the Peer-to-Peer Learning and Training Course on Philanthropy for Climate Action in Asia and the Pacific in Bangkok, Thailand**

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Mr. Milton Chandra Roy, Senior Assistant Secretary**, Ministry of Environment, Forest and Climate Change, to participate in the Peer-to-Peer Learning and Training Course on Philanthropy for Climate Action in Asia and the Pacific, scheduled to be held from **27 to 28 February 2025 in Bangkok, Thailand**. This approval is granted in accordance with the terms and conditions outlined below:

2. Terms and conditions

- i. The official will commence his journey for Bangkok on a convenient date near 27 February 2025;
- ii. The duration of the program, including travel and transit time, will be treated as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. UNDP and the Climate Finance Network (CFN) will cover all expenses related to his participation. **There will be no financial involvement from the Government of Bangladesh;**
- v. He will not stay abroad beyond the approved period (except for travel time);
- vi. He must return to his workplace after completing the training program; and
- vii. He is required to submit a report on the program to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.
