Subject: **Government Order (GO) for Participation in the Regional Workshop on Gender, Environment and Climate Change Statistics in Bangkok, Thailand**

The undersigned is directed to convey the approval of the Ministry of Environment, Forest and Climate Change, Government of the People's Republic of Bangladesh, for **Mr. Milton Chandra Roy, Senior Assistant Secretary**, Ministry of Environment, Forest and Climate Change, Dhaka, to participate in the "Regional Workshop on Gender, Environment and Climate Change Statistics" scheduled to be held from **5 to 7 May 2025** at the United Nations Conference Centre (UNCC) in **Bangkok, Thailand**, organized by the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP) and UN Women. This approval is accorded under the following terms and conditions:

2. Terms and conditions

- i. The official may commence his journey to Bangkok, Thailand on 04 May 2025 or on a convenient date close to 5 May 2025, and may return on 08 May 2025 or another suitable date after the completion of the program;
- ii. The entire duration of the visit, including travel and transit, shall be considered as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to his participation will be borne by the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP) and UN Women. **There will be no financial involvement from the Government of Bangladesh;**
- v. He will not stay abroad beyond the approved period (except for travel time);
- vi. He must report back to his office immediately upon completion of the program; and
- vii. He is required to submit a report on the workshop to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.

3. This order is issued with the approval of the competent authority.
