2. The following terms and conditions will be applicable for this tour:

- While participating in the sessions and on journey to and from Riyadh, Kingdom of Saudi Arabia they will be treated as on duty;
- They will draw their pays and allowances in local currency during the aforesaid period.

- iii. All expenses of the nominees in connection with this visit will be borne by the sponsoring funding body UNCCD, Food and Agriculture Organization (FAO) and Bangladesh Climate Change Trust Fund (BCCT). If the funding body does not bear any part of the expenses of Hon'ble Advisor (Head of delegation), Secretary, MoEFCC and DG, DoE according to their entitlement, rest of the expenses will be borne by the Government of Bangladesh as per existing rules.
 - iv. Dr. Abdul Hamid, Director General, Department of Environment, Bangladesh will extend his stay in Kingdom of Saudi Arabia from 14-16 December 2024 to perform Umrah which will be borne by himself.
 - v. They will not stay abroad beyond the approved period (excluding travel time).
 - vi. They will submit a report on the acquired experiences to this Ministry within 10 working days after their return to Bangladesh.
