Subject: **Government Order for Participation in the “GTI General Assembly, Ministerial Roundtable, and World Environment Day 2025” in Jeju, Republic of Korea**

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Her Excellency Ms. Syeda Rizwana Hasan**, Honorable Adviser, Ministry of Environment, Forest and Climate Change, and **Mr. Mirza Shawkat Ali**, Director, Department of Environment, to attend the GTI General Assembly, Ministerial Roundtable, and the World Environment Day 2025 Commemoration Ceremony, scheduled to be held from **4 to 5 June 2025** in **Jeju, Republic of Korea**. This approval is granted under the following terms and conditions:

2. Terms and conditions

- i. The delegates may commence their journey to the Republic of Korea on a convenient date near **3 June 2025** and return after the completion of the events;
- ii. The duration of the visit, including travel and transit, will be treated as on duty;
- iii. They will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. All expenses related to their participation in the above-mentioned events will be borne by the Ministry of Environment of the Republic of Korea. **There will be no financial involvement from the Government of Bangladesh;** and
- v. The delegates shall not stay abroad beyond the approved period, except for necessary travel time.
- vi. Mr. Mirza Shawkat Ali is required to submit a report on the events to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven (07) days of his return, and report back to his office immediately upon completion of the program.
