2. Terms and conditions
 - i. The official will commence her journey to Thailand on or around 13 October 2025 and return on or around 17 October 2025, subject to travel convenience;
 - ii. The entire duration of the visit, including travel and transit, shall be considered as on duty;
 - iii. She will draw her pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - iv. All expenses related to her participation in the program will be borne by the Asian Disaster Preparedness Center (ADPC). **There will be no financial involvement from the Government of Bangladesh;**
 - v. She will not stay abroad beyond the approved period (except for travel time);
 - vi. She must report back to her office immediately upon completion of the program; and
 - vii. She is required to submit a report on the dialogue to the Administration -2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.
