Subject: **Government Order (GO) for Participation in the Capacity Building Program on Climate Services for FEWH Sectors in Indonesia, August 2025**

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for the following officials to participate in the "Capacity Building Program on Climate Services for Food, Energy, Water, and Health (FEWH) Sectors to Close the Early Warning Gap in Climate Resilience" jointly organized by the Ministry of State Secretariat (MoSS) and the Indonesian Agency for Meteorology, Climatology and Geophysics (BMKG) in collaboration with the Colombo Plan. The program will be held in a hybrid format with an **online phase from 11 to 15 August 2025**, and an in-person phase in Tangerang, **Banten, Indonesia** from **24 to 30 August 2025**.

2. Terms and conditions
 - i. The officials will participate in the online phase from Bangladesh between 11–15 August 2025, and travel to Indonesia on or around 23 August 2025, returning after the in-person phase, depending on travel convenience;
 - ii. The entire duration of the program, including travel and transit, will be treated as on duty;
 - iii. They will draw their pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - iv. All expenses related to their participation will be borne by the Colombo Plan and the Government of Indonesia. **There will be no financial involvement from the Government of Bangladesh;**
 - v. They will not stay abroad beyond the approved period (except for travel time);
 - vi. They must report back to their respective offices immediately upon return; and
 - vii. A report on the program must be submitted to the Admin-2 Section of the Ministry within seven working days of return.
