- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. They will draw their pay and allowances in **local currency**, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to participation in the training programme, including international airfare, accommodation, daily subsistence allowance, and other related costs, will be borne by the organizing authority (JICA). **There will be no financial involvement from the Government of Bangladesh;**
- v. The officials shall **not stay abroad beyond the approved period**, except for reasonable travel time;
- vi. They must **report back to their respective offices immediately** upon return; and
- vii. A **brief participation report** must be submitted to the **Administration-2 Section**, Ministry of Environment, Forest and Climate Change, within **seven (07) days** of their return.
