- The official shall **not stay abroad beyond the approved period**, except for reasonable travel time;
- She must **report back to her office immediately** upon return; and
- A **brief participation report** must be submitted to the **Administration-2 Section**, Ministry of Environment, Forest and Climate Change, within **seven (07) days** of her return.
