Government Order

2. This approval is accorded under the following terms and conditions:

- i. The official will undertake travel to Bhutan on or around **15 February 2026** and return on or around **20 February 2026**, subject to travel convenience and approved programme schedule;
- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to participation in the workshop, including airfare, accommodation, daily subsistence allowance, and local transportation, will be borne by the **organizers (UNEP and ICIMOD)** under the **A@A Programme**. There will be no financial involvement from the **Government of Bangladesh**;
- v. The official shall **not stay abroad beyond the approved period**, except for reasonable travel time;
- vi. He must **report back to his office immediately** upon return; and
- vii. A **brief participation report** must be submitted to the **Administration-2 Section, Ministry of Environment, Forest and Climate Change**, within **seven (07) days** of his return.
