Government Order



2. This approval is accorded under the following terms and conditions:

- i. The official will undertake travel to Malaysia on or around **3 February 2026** and return on or around **7 February 2026**, subject to travel convenience and approved programme schedule;
- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to participation in the training workshop, including airfare, accommodation, and subsistence, will be borne by the **Commonwealth** under its agreement with the **GEF Secretariat**. There will be no financial involvement from the **Government of Bangladesh**;
- v. The official shall not stay abroad beyond the approved period, except for reasonable travel time;
- vi. He must report back to his office immediately upon return; and
- vii. A brief participation report must be submitted to the **Administration-2 Section**, Ministry of Environment, Forest and Climate Change, within **seven (07) days** of his return.
