**Government Order**

2. This approval is accorded under the following terms and conditions:


- The officials will undertake travel to Sri Lanka on or around **16 February 2026** and return on or around **20 February 2026**, subject to travel convenience and flight availability;
- The entire duration of the visit, including travel and transit, shall be treated as on duty;
- They will draw their pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- SACEP is currently exploring the possibility of funding all workshop-related expenses for participants. While these details are **pending final approval**, it is expected that all costs—including travel and subsistence—will be borne by SACEP. These arrangements will entail **no financial obligation** from the Government of Bangladesh;
- The officials shall not stay abroad beyond the approved period, except for reasonable travel time;
- They must report back to their respective offices immediately upon return; and
- A **brief participation report** must be submitted to the **Administration-2 Section**, Ministry of Environment, Forest and Climate Change, within **seven (07) days** of his return.
