GOVERNMENT ORDER

The undersigned is directed to convey the deputation permission of the Government of the People's Republic of Bangladesh in favour of Mr. Md Hannan (Passport No.: E00222576), Assistant Director, Department of Environment, Agargaon, Dhaka to study Master's Program for Future Global Leaders in Environmental Policy (MGLEP) at the International School of Urban Sciences (ISUS), University of Seoul under a fully-funded scholarship program from 15 February 2026 to 09 January 2028 (excluding travel time) in South Korea. This scholarship program will be jointly funded by University of Seoul and the Ministry of Climate, Energy and Environment of the Republic of Korea.

2. The terms and conditions of these orders are as follows:
 - a. He will not claim any extra convenience/promotion for completing the course;
 - b. There will be no financial involvement of Bangladesh Government in it;
 - c. The course must be successfully completed within this period;
 - d. He will not stay abroad beyond the approved period. He has to join at his workplace immediately after the completion of his course;
 - e. He has to submit a commitment letter on 300 Tk. Non-judicial stamp paper;
 - f. He will not apply for the extension of duration or change of the course;
 - g. He will submit the completion certificate to the Government after the completion of his course; and
 - h. He will draw his salary and allowances as per the existing rules of Government in local currency during this period from his main work place.
