2. This approval is accorded under the following terms and conditions:


- i. The official is scheduled to travel to Ethiopia on or around **26 April 2026** and return on or around **1 May 2026**, subject to travel convenience and approved programme schedule;
- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to participation in the programme, including international airfare, accommodation, daily subsistence allowance (DSA), and other associated expenses, will be borne by the Climate Investment Funds (CIF). **There will be no financial involvement from the Government of Bangladesh;**
- v. The officials shall **not stay abroad beyond the approved period**, except for reasonable travel time;
- vi. He must report back to his office immediately upon return; and
- vii. A brief participation report must be submitted to the Administration-2 Section, Ministry of Environment, Forest and Climate Change, within seven (07) days of his return.
