Government Order

2. This approval is accorded under the following terms and conditions:
- The official will undertake travel to China on or around **21 April 2026** and return on or around **27 April 2026**, subject to travel convenience and approved programme schedule;
 - The entire duration of the visit, including travel and transit, shall be treated as on duty;
 - He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - All expenses related to participation in the meeting, including international airfare, accommodation, daily subsistence allowance (DSA), and other associated expenses, will be borne by APFNet. **There will be no financial involvement from the Government of Bangladesh;**
 - The official will not stay abroad beyond the approved period (except for unavoidable travel time);
 - He must report back to his office immediately upon return; and
 - A brief participation report must be submitted to the Administration-2 Section, Ministry of Environment, Forest and Climate Change, within seven (07) days of his return.


