**Government Order**

The undersigned is directed to convey the approval of the Ministry of Environment, Forest and Climate Change, Government of the People's Republic of Bangladesh, for the following officials to participate in the "Regional Dialogue on the Project 'South Asia Region Capacity Building for Pandemic Prevention, Preparedness, and Response (PPR) with One Health Approach'" and the "Project Technical Working Group Meeting on Early Warning and Surveillance", organized by the Food and Agriculture Organization (FAO), to be held from 2-5 June 2026 in Bangkok, Thailand.

2. This approval is accorded under the following terms and conditions:


- i. The officials are scheduled to travel to Bangkok, Thailand on or around 1 June 2026. Mr. Md Masudur Rahman is scheduled to return on or around 4 June 2026, and Mr. M. K. M. Iqbal Husain Chowdhury is scheduled to return on or around 6 June 2026, subject to travel convenience and approved programme schedule;
- ii. Mr. M. K. M. Iqbal Husain Chowdhury will participate in **both** the Regional Dialogue scheduled on 2-3 June 2026 and the Project Technical Working Group Meeting on Early Warning and Surveillance scheduled on 4-5 June 2026, while Mr. Md. Masudur Rahman will participate **only in the Regional Dialogue** scheduled on 2-3 June 2026;
- iii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iv. They will draw their pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- v. All expenses related to participation in the programme, including international airfare, accommodation, and daily subsistence allowance (DSA), will be borne by the Food and Agriculture Organization (FAO). **There will be no financial involvement from the Government of Bangladesh;**
- vi. The officials shall not stay abroad beyond the approved period, except for reasonable travel time;
- vii. They must report back to their respective offices immediately upon return; and
- viii. A **brief participation report** must be submitted to the **Administration-2 Section**, Ministry of Environment, Forest and Climate Change, within **seven (07) days** of their return.
