Government Order

2. This approval is accorded under the following terms and conditions:


- i. The officials are scheduled to travel to South Korea on or around **10 May 2026** and return on or around **14 May 2026**, subject to travel convenience and approved programme schedule;
- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. They will draw their pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to participation in the programme, including international airfare, accommodation, internal transportation, daily subsistence allowance (DSA), and other associated expenses, will be borne by the Government of the Republic of Korea. **There will be no financial involvement from the Government of Bangladesh;**
- v. The officials shall not stay abroad beyond the approved period, except for reasonable travel time;
- vi. They must report back to their respective offices immediately upon return; and
- vii. A **brief participation report** must be submitted to the **Administration-2 Section**, Ministry of Environment, Forest and Climate Change, within **seven (07) days** of their return.
