2. This approval is accorded under the following terms and conditions:

- The officials is scheduled to travel to Thailand in connection with the above meetings, subject to flight availability and programme schedule;
- The entire duration of the visit, including travel and transit, shall be treated as on duty;
- He will draw his pay and allowances in local currency. No part thereof shall be drawn in foreign currency;
- The Secretariat of the Montreal Protocol will bear the round-trip economy-class airfare, accommodation, daily subsistence allowance (DSA), and other related expenses under the funding arrangements for Article 5 Parties. There shall be no financial involvement from the Government of Bangladesh;
- He shall not remain abroad beyond the approved period except for reasonable travel time;
- He shall report to his office immediately upon return; and
- A **brief participation report** must be submitted to the **Administration-2 Section**, Ministry of Environment, Forest and Climate Change, within **seven (07) days** of his return.
