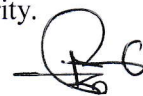

Government Order

The undersigned is directed to convey the approval of the Ministry of Environment, Forest and Climate Change, Government of the People's Republic of Bangladesh, for the following official to participate in the **8th World Heritage Site Managers Forum**, scheduled to be held from **16-23 July 2026** in **Busan, Republic of Korea**.

2. This approval is accorded under the following terms and conditions:
- The official is scheduled to travel to the Republic of Korea in connection with the above Forum, subject to flight availability and programme schedule;
 - The entire duration of the visit, including travel and transit, shall be treated as on duty;
 - He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - The Government of the Republic of Korea and the organizers (UNESCO World Heritage Centre) will bear the round-trip economy-class airfare, hotel accommodation and other approved expenses related to participation in the Forum. There shall be no financial involvement from the Government of Bangladesh;
 - The official will not stay abroad beyond the approved period (except for unavoidable travel time);
 - He must report back to his office immediately upon return; and
 - He is required to submit a brief report on the program to the **Administration-2 Section**, Ministry of Environment, Forest and Climate Change within seven (07) days of his return.
