**Government Order**

2. This approval is accorded under the following terms and conditions:
- The Honourable Minister is scheduled to travel to Bangkok, Thailand on or around 30 June 2026 and return on or around 6 July 2026, subject to travel convenience and the approved programme schedule;
  - The period from 1–3 July 2026 for participation in the official events, together with the necessary travel and transit time, shall be treated as on official duty;
  - The Honourable Minister will draw his pay and allowances in local currency, and no part thereof shall be drawn in foreign currency;
  - The travel, accommodation, and other admissible expenses relating to participation in the official events will be borne by the organizers/host authorities. There will be no financial involvement from the Government of Bangladesh;
  - Following completion of the official programme, the Honourable Minister is permitted to remain in Bangkok from 4 to 6 July 2026 for a personal medical check-up. All expenses related to this extended stay, including accommodation, local transportation, medical expenses, and any incidental costs, shall be borne personally by the Honourable Minister, with no financial involvement from the Government of Bangladesh; and
  - The Honourable Minister shall not remain abroad beyond the approved period, except for reasonable travel time and the above-mentioned privately funded extension.
3. This order is issued with the approval of the competent authority.
