Government Order

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Ms. Nazmun Nahar Hossain (Passport No. F00194809), Wildlife & Biodiversity Conservation Officer**, Bangladesh Forest Department, to participate in the training on "Addressing Marine Species Trafficking," scheduled to be held from **30 June to 02 July 2026** in **Kalutara, Sri Lanka**, jointly organized by the United Nations Office on Drugs and Crime (UNODC) and the Government of Sri Lanka.

2. This approval is accorded under the following terms and conditions:
- She is scheduled to travel to Sri Lanka in connection with the above training programme, subject to flight availability and programme schedule;
 - The entire period of the visit, including travel and transit, shall be treated as on duty;
 - She will draw her pay and allowances in local currency. No part thereof shall be drawn in foreign currency;
 - The United Nations Office on Drugs and Crime (UNODC) will bear the round-trip economy-class airfare, accommodation, daily subsistence allowance (DSA), and other approved expenses related to her participation. **There shall be no financial involvement from the Government of Bangladesh;**
 - The official will not stay abroad beyond the approved period (except for unavoidable travel time);
 - She shall report to her office immediately upon return; and
 - She shall submit a brief report on the events to the Administration-2 Section, Ministry of Environment, Forest and Climate Change, within seven (07) working days of her return.
3. This order is issued with the approval of the competent authority.
