Government Order

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Mr. Md Mahiuddin Manik (Passport No. E00183795)**, Deputy Director, Department of Environment, Headquarters, Dhaka, to participate in the Forty-Eighth Meeting of the Open-ended Working Group of the Parties to the Montreal Protocol (OEWG48) and the UNIDO Side Event titled "Advancing Energy Efficiency in RAC Manufacturing: Lessons, Data and Pathways for Article 5 Countries", scheduled to be held from **13–17 July 2026 in Bangkok, Thailand**.

2. This approval is accorded under the following terms and conditions:
 - i. He is scheduled to travel to Thailand in connection with the above meeting and side event, subject to flight availability and programme schedule;
 - ii. The entire period of the visit, including travel and transit, shall be treated as on duty;
 - iii. He will draw his pay and allowances in local currency. No part thereof shall be drawn in foreign currency;
 - iv. The **United Nations Industrial Development Organization (UNIDO)** will bear the round-trip economy-class airfare, accommodation, daily subsistence allowance (DSA), and other approved expenses related to his participation in the meeting and side event. There shall be no financial involvement from the Government of Bangladesh;
 - v. The official will not stay abroad beyond the approved period (except for unavoidable travel time);
 - vi. He shall report to his office immediately upon return; and
 - vii. He shall submit a brief report on the events to the Administration-2 Section, Ministry of Environment, Forest and Climate Change, within seven (07) working days of his return.
