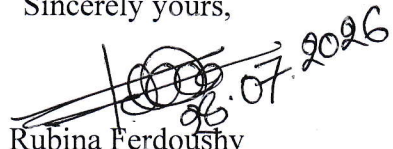
Government Order

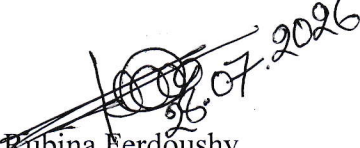
