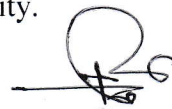

Government Order

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Mr. Syed Ahmmad Kabir** (Passport No. E00113517), Deputy Director (Enforcement), Department of Environment, Dhaka, to participate in the Twenty-second Meeting of the Persistent Organic Pollutants Review Committee (POPRC-22), scheduled to be held from **21–25 September 2026 in Rome, Italy**.

2. This approval is accorded under the following terms and conditions:
- He is scheduled to travel to Italy in connection with the above meeting, subject to flight availability and programme schedule;
 - The entire duration of the visit, including travel and transit, shall be treated as on duty;
 - He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - The Secretariat of the Basel, Rotterdam and Stockholm Conventions (BRS Secretariat) will bear the round-trip economy-class airfare and other approved expenses related to his participation in the meeting. **There shall be no financial involvement from the Government of Bangladesh;**
 - He shall not remain abroad beyond the approved period except for reasonable travel time;
 - He shall report to his office immediately upon return; and
 - He shall submit a brief report on the meeting to the Administration-2 Section, Ministry of Environment, Forest and Climate Change, within seven (07) working days of his return.
